## CIRCULAR

Sub: Haj-2012. Payment of Haj Amount in case of provisionally selected Pilgrims and the Pilgrims confirmed against surrendered quota.

Kindly refer to the subject cited above. In this regard, it is to inform that, out of the total 1,14,000 seats confirmed by the Haj Committee of India against original quota and against surrendered seats available, around 4000 Pilgrims have not remitted Advance Haj Amount @ Rs. 51,000/- per Pilgrim to the Haj Committee of India, till date. It may not be out of place to mention here that the last date of remittance of Haj Amount in case of originally selected Pilgrims was fixed as 11<sup>th</sup> June, 2012, where as the date fixed for the Pilgrims whose seats have been confirmed against surrendered seats was 30<sup>th</sup> June, 2012.

As you are aware that, Haj is a time bound programme. Any delay in the calendar of activities will hamper the smooth functioning of Haj Movement. Accordingly, it has now been decided that, those provisionally selected Pilgrims against original quota or against surrendered seats available, will have to remit Haj Amount through Core Banking System to the Haj Committee of India, till 16<sup>th</sup> July, 2012 positively, else we will be constrained to cancel their seats, and allot their seats to the Waiting list Pilgrims in serial order. Please inform the Pilgrims that, it will not be possible for this office to extend the last date for remittance of Rs. 51,000/- advance Haj Amount beyond 16<sup>th</sup> July, 2012. The list of provisionally selected Pilgrims who are yet to remit Haj Amount @ Rs. 51,000/- per Pilgrim will be available on our website: [www.hajcommittee.com](http://www.hajcommittee.com). If any Pilgrim has already has already paid Rs. 51,000/- and if his name is appearing in the defaulters list, they should send the copy of bank pay-in-slip to this office immediately by fax on 022-2263 0463, for rectification. They may also contact Mr. Rehman Khawja on Mobile No. 097574 65926. Please note that, once Cancellation is marked due to non-payment of Rs. 51,000/- on or before 16<sup>th</sup> July, 2012, no revocation will be made, under any circumstances.

The Executive Officer / Secretary of the State / Union Territory Haj Committees are requested, kindly to inform the provisionally selected Pilgrims to remit the Advance Amount if not remitted as yet, to this office, within the extended prescribed date i.e. 16<sup>th</sup> July, 2012, positively, to avoid cancellation of their seats. Please give wide publicity to the defaulters list, through all means of communication.
