

Subject : Release of waiting list for Haj - 2015

Ministry of External Affairs, Government of India has vide its letter dated 01.07.2015 communicated that the discretionary quota of 75 seats earmarked for Hon'ble Prime Minister is to be distributed to wait-listed pilgrims of Haj - 2015. Further, 180 seats have become available due to cancellations received from under-quota States. A statement showing the wait listed pilgrims for Haj - 2015 who are now provisionally selected against the aforesaid 255 seats (75+180) distributed as per Muslim population and cancellations received from the respective states (306 seats) is annexed .

2. The aforesaid provisionally selected pilgrims have to deposit the entire Haj Amount as per their category of accommodation and embarkation point. The pilgrims may be advised that after depositing the amount in the bank, pay-in-slips and original valid machine readable international passport with one photograph attached to the back of passport with adhesive tape should be submitted in their respective State Haj Committee on or before **03-08-2015**, failing which the provisionally selection shall be treated cancelled.

3. The Haj Applications, passports and pay-in-slips may be submitted by SHC to this office by **10-08-2015**.
