Subject : Haj-2016 : Release of Waiting List for Haj – 2016

In continuation to this office Circular No. 27, dated 29th July, 2016, further **1034** seats have become available due to cancellations received from various States out of which **597** seats are from Under-Quota States, Lap-1 States and Khadimul Hujjaj. A statement showing cancellations received from the respective States and the wait-listed pilgrims for Haj – 2016, who are now provisionally selected in terms of Guidelines for Haj – 2016, distributed as per Muslim Population is annexed.

2. In terms of this office letter No.HC-18/105/2015-16/2306, dated 9th August, 2016, State/U.T. Haj Committees concerned, who have already collected original valid International passports (along with recent passport size photograph) in the serial order of waiting list along with Undertaking, should forward the same to this office on an urgent basis, along with the statement in the proforma justifying skipping of waiting list number. The skipping list should be duly certified by the Executive Officer of respective State / UT Haj Committee. All such provisionally selected pilgrims will have to deposit their total Haj Amount as per category of accommodation within 3 days and submit the original pay-in-slip directly to Haj Committee of India.

3. The selection from waiting list shall be purely provisional and subject to Visa endorsement by Royal Consulate of Saudi Arabia, Mumbai failing which, Haj Committee of India will be constrained to cancel the provisional selection.
