In States/UTs where the quota is less than the number of applicants for Haj, selection of Haj pilgrims is done by computerised draw of lots (qurrah). While the process of qurrah is carried out on the IHPMS software on Central Server of Haj Committee of India, the display of selection is organised by respective State/UT Haj Committees.

2. For Haj-2017, all States/UTs were asked to fix the dates for qurrah within the period of 14 – 21 March, 2017. All States/UTs where the applicants were more than their quota have completed the qurrah as per schedule, except Karnataka.

3. Karnataka State Haj Committee asked for qurrah to be held on 30.03.2017. It was pointed out by this office that postponement to such a late date would cause inconvenience to the selected pilgrims as they will be left with little time to make payment. Further the connected activities of Haj Committee of India would also be unduly delayed as the numbers of pilgrims in various categories and Embarkation Points can not be finalised unless all pilgrims are selected. However, Karnataka State Haj Committee did not agree to fix the qurrah within the scheduled time.

4. Accordingly, it was decided to conduct the qurrah for selection of pilgrims of Karnataka State on 23.03.2017 at 3.00 p.m. in this office with due intimation to Karnataka State Haj Committee. The details of Haj Application Forms received in different categories and quota allotted to Karnataka States is in Annexure – 'A'. The qurrah was done districtwise as per past practice. The SMS of selection have been sent to the head of the selected covers.
