Sub : Restoration of Haj Committee of India Quota - Regarding.

Vide letter bearing F.No.4/27/2017-Haj dated 4th December, 2017 (copy enclosed), the Ministry of Minority Affairs (Haj Division), Government of India has conveyed that in view of suggestions from various quarters and after due consideration, it has been decided by the Competent Authority to maintain the Haj Quota sharing between HCoI and PTOs to Haj – 2018 in the same ratio as prevailed in Haj – 2017. Accordingly, point 10.1 in Haj Guidelines for Haj – 2018 stands corrected as above.
