Sub: Remarks against 48 PTOs registered by Government of Saudi Arabia during Haj-2012.

Saudi Asian Moassasa, Makkah had forwarded on February 07, 2013 a list (placed below) of forty eight (48) PTOs against whom violations/remarks were registered during Haj-2012 by the Saudi Ministry of Haj. All the forty eight (48) PTOs against whom violation/remarks were registered during Haj 2012 have now been cleared by the Saudi Ministry of Haj **with ultimatum stating that all private companies, agencies and Associations must abide by the instructions framed by the Saudi Government for arrival of Hajis with an emphasis that in case of repeat of such violations, taking of other actions against the concerned PTO will be considered to ensure the abidance of the instructions.**

All the concerned PTOs are advised to abide by the instructions of Saudi Ministry of Haj in future.

Actions taken against the organizers of arrival of Hajis from abroad among the private companies, agencies and associations against whom violations and remarks were registered during the Haj season 1433H.
