THE TENTATIVE HAJ AMOUNT IS SUBJECTED TO 10 % INCREASE OR DECREASE BASED UPON ACTUAL EXPENDITURE TO BE INCURRED FOR MAKING ARRANGEMENTS. PILGRIMS WHO HAVE ALREADY PAID AMOUNT OF RS. 2,51,800/- (RS. 81,800/- + RS. 1,70,000/-) NEED TO DEPOSIT THE BALANCE AMOUNT.

- 2. Those pilgrims who opted for Qurbani/Adahi have to pay an additional amount of Rs. 16,344/- (equivalent to 720 SAR) per Pilgrim. The amount is to be paid to HCoI by using appropriate Pay-in-Slip attached with the Haj Guidelines for Haj-2023 in any branch of State Bank of India OR Union Bank of India OR online at www.hajcommittee.gov.in.
- 3. Before paying the Balance Haj Amount, Pilgrims must verify the exact amount payable by them on Haj Committee of India website **www.hajcommittee.gov.in**. Payment challan can also be generated from the website.
- 4. Shia Pilgrims embarking from Bhopal, Delhi, Gaya, Guwahati, Indore, Jaipur, Kolkata, Lucknow, Ranchi, Srinagar and Varanasi to proceed to Madina Haj Terminal and opting for JOHFA as MEEQAT, are required to pay extra Rs.24,904/- (equivalent to 1097.1 SAR) per pilgrim. Shia Pilgrims embarking from Ahmedabad, Aurangabad, Bangaluru, Calicut, Chennai, Cochin, Hyderabad, Kannur, Mumbai, Nagpur and Vijayawada to proceed to Jeddah Haj Terminal and opting for JOHFA as MEEQAT, are required to pay extra Rs.26,314/- (equivalent to 1159.2 SAR) per pilgrim.
- 5. Those who opted for Rubat and have been allotted Rubat will be refunded the collected tentative accommodation component of expenditure on priority basis.
- 6. The Last date for payment of the Haj Amount is 15.05.2023. Flights are likely to commence from 21.05.2023. Pilgrims will not be allowed to board the flight if all dues are not paid.
