As on date, 1100 Haj seats have become available due to cancellations of applications on various grounds. Accordingly, waitlisted applicants, as per Annexure-I, have been provisionally selected for Haj-2025.

- 2. The aforementioned provisionally selected pilgrims are required to deposit Full Haj Amount (i.e. First Installment ₹1,30,300.00 (+) Second Installment ₹1,42,000.00 (+) Third Installment as per Circular No. 36 dated 19<sup>th</sup> March 2025) **latest by 15<sup>th</sup> April, 2025**.
- 3. Payment of Haj Amount, as specified in the aforementioned Circular No. 36, can be made either through:
  - a. E-payment facility available of <a href="https://hajcommittee.gov.in">https://hajcommittee.gov.in</a> or Haj Suvidha App using Credit Card / Debit Card / Net Banking.

OR

- b. Specified Pay-in-Slip in any branch of State Bank of India or Union Bank of India in the account of Haj Committee of India using Bank Reference Number available on the website against each cover number.
- 4. The unique **Bank Reference Number** provided to each Cover must be mentioned in the Deposit Receipt.
- 5. After depositing the specified amount, the provisionally selected pilgrims must submit the following documents to the concerned State/UT Haj Committees latest by 16<sup>th</sup> April, 2025.
  - a. Original Passport
  - b. Haj Application Form (HAF)
  - c. Solemn declaration and undertaking
  - d. A copy of Pay-in-Slip / online receipt
  - e. Medical Screening & Fitness certificate (as per format available on the website)
  - f. Self-attested copy of machine-readable international passport

6. The State/UT Haj Committees shall upload all the aforementioned documents on the web portal of Haj Committee of India immediately upon receipt from the pilgrims. The original passports may be handled by SHCs as per SOP issued by Haj Committee of India on 3<sup>rd</sup> February, 2025.
