CIRCULAR

Subject: Release of Eighth Waiting List for Haj-2025.

As on date, **60** Haj seats have become available due to cancellation of applications on various grounds. Accordingly, wait-listed applicants, as per Annexure-I, have been provisionally selected for Haj-2025 in the order of their position in the skipping list prepared based on willingness of applicants in accordance with the provision of Circular No. 37 dated 28th March, 2025. This selection is subject to visa issuance and availability of flight seats. The Haj Committee of India reserves the right to change preferred embarkation point of these pilgrims in view of operational necessity.

- 2. The aforementioned provisionally selected pilgrims are required to deposit Full & Final Haj Amount (i.e. First installment Rs.1,30,300/- (+) Second installment Rs.1,42,000/- (+) 3rd installment, as per Circular No. 36 dated 19th March, 2025) latest by **26.05.2025.**
- 3. Payment of Haj Amount, as specified in the aforementioned Circular No. 36, can be made either through:
 - a. E-payment facility available on https://hajcommittee.gov.in or Haj Suvidha App using Credit Card / Debit Card / Net Banking

- b. Specified Pay-in-Slip in any branch of State Bank of India or Union Bank of India in the account of Haj Committee of India using Bank Reference Number available on the website against each cover number.
- 4. The unique **Bank Reference Number** provided to each Cover must be mentioned in the Despite Receipt.
- 5. After depositing the specified amount, the provisionally selected pilgrims must submit the following documents to the concerned State/UT Haj Committees immediately.
 - a. Original Passport
 - b. Haj Application Form (HAF)
 - b. Solemn declaration and undertaking
 - c. A copy of Pay-in-Slip / online receipt
 - d. Medical screening & fitness certificate (as per format available on the website)
 - e. Self-attested copy of machine-readable international passport
- 6. The State/UT Haj Committees shall upload all the aforementioned documents on the web portal of Haj Committee of India immediately upon receipt from the pilgrims. The original passports may be handled by SHCs as per SOP issued by Haj Committee of India on 3rd February, 2025.
