## Subject: Extension of Last Date for Deposit of Advance Haj Amount and Declaration of Short Haj Pilgrims

Reference to Circular No. 08 dated 13.08.2025, the last date for deposit of ₹1,52,300.00 (Advance Haj Amount - ₹1,50,000.00; Miscellaneous Dues - ₹2,000.00; and Non-Refundable Processing Fee - ₹300.00) is hereby extended up to 25.08.2025. All the provisionally selected pilgrims, including those opted for Short Haj, are required to make the payment within the stipulated time without fail.

- It is also notified that the applicants who had opted for Short Haj and were provisionally selected for Haj during the Qurrah (Digital Random Selection) process have been allotted the Short Haj Package.
- The payment, as specified above, can be made either through:
  - E-payment facility available on <a href="https://hajcommittee.gov.in">https://hajcommittee.gov.in</a> or Haj Suvidha App using Credit Card / Debit Card / Net Banking

OR

- b. Specified Pay-in-Slip in any branch of State Bank of India or Union Bank of India in the account of Haj Committee of India using Bank Reference Number available on HCoI website against each Cover number.
- 4. The unique Bank Reference Number provided to each Cover must be mentioned in the Deposit Receipt.
- After depositing the amount, the pilgrims must upload the following documents on the HCol website OR submit to the concerned State/UT Haj Committee latest by 30.08.2025.
  - Signed copy of Haj Application Form (HAF) along with solemn declaration and undertaking
  - b. Copy of pay-in-slip / online receipt
  - c. Medical screening & fitness certificate (as per format available on the website)
- The State/UT Haj Committees shall upload all the aforementioned documents on the web portal of Haj Committee of India immediately upon receipt from the pilgrims.
- 7. The pilgrims should strictly adhere to the stipulated last date for deposit of Advance Haj Amount and submission of documents failing which their Haj seat shall be liable to be cancelled.
