NOTICE

This is in reference to representations received in respect of CHGO/HGO Policy for Haj 2026 issued by this Ministry vide Notice No. HAJ-15/4/2025-HAJ-MoMA (e-147347) dated 25.08.2025.

- 2. The issues so raised have been examined and issue-wise clarifications in respect of CHGO/HGO Policy for Haj-2026, as approved by the competent authority, are as under:
- A. Submission of Extended Fixed Deposit Receipt (FDR) (Point no. 9 of the HGO policy for Haj 2026)

Concerns flagged / representations received:

- i. The bank where the HGO has created the FDR is not allowing an extension of the existing FDR and is insisting that the old FDR must first be deposited and cancelled, after which a new FDR can be issued.
- ii. Instead of extended FDR, HGOs be allowed to submit a Bank Guarantee.

Clarification: In case the Bank is not issuing extended FDR, then CHGOs/HGOs may either submit a fresh FDR or a Bank Guarantee with validity upto 31.12.2026.

B. Submission of Munazzam Card and Haj Visa Details

Concerns flagged / representations received: Difficult for HGOs to arrange Munazzam Card and Haj visa pages for all the years in respect of all Munazzam.

Clarification: Submission of Munazzam card and Haj visa pages of passport related details have been relaxed.

C. Execution of Supplementary LLP Agreement / MoU for CHGOs

Concerns flagged / representations received:

i. Whether it is mandatory to execute a supplementary LLP Agreement to induct HGOs as Partners in the LLP, or whether the composition of the CHGO may continue with the original Partners, and the newly confirmed HGOs may only be covered through the MoU without formal induction into the LLP deed.

Clarification: It is upto the CHGO to either execute an LLP Agreement or submit a MoU indicating inclusion of HGOs as Partners.

- 3. It has further been decided that the last date for submission of documents by CHGOs / HGOs with regard to Haj 2026 on the PTO Portal i.e., pto.haj.gov.in, has been extended till 15.09.2025.
- 4. This issues with the approval of the Competent Authority.
