### Subject: Release of First Waiting List for Haj-2026 G (1447 H)

The Haj Committee of India (HCoI) is pleased to announce the release of the **First Waiting** List comprising 22,530 seats for Haj–2026 G (1447 H). Accordingly, waitlisted applicants, detailed in **Annexure–I**, have been provisionally selected for Haj–2026 G (1447 H) as per their preference for Short Haj or Normal Haj.

- 2. The aforementioned applicants are required to deposit ₹1,52,300.00 (Advance Haj Amount ₹1,50,000.00; Miscellaneous Dues ₹2,000.00; and Non-Refundable Processing Fee ₹300.00) latest by 11.10.2025.
- 2. The payment, as specified above, can be made either through:
  - a. E-payment facility available on <a href="https://hajcommittee.gov.in">https://hajcommittee.gov.in</a> or Haj Suvidha App using Credit Card / Debit Card / Net Banking

OR

- b. Specified Pay-in-Slip in any branch of State Bank of India or Union Bank of India in the account of Haj Committee of India using Bank Reference Number available on HCoI website against each Cover number.
- 3. The unique Bank Reference Number provided to each Cover must be mentioned in the Deposit Receipt.
- 4. After depositing the amount, the pilgrims must upload the following documents on the HCoI website OR submit to the concerned State/UT Haj Committee latest by **18.10.2025**.
  - a. Signed copy of Haj Application Form (HAF) along with solemn declaration, undertaking, and passport declaration form
  - b. Copy of pay-in-slip / online receipt
  - c. Medical screening & fitness certificate (as per format available on the website)
- 5. The State/UT Haj Committees shall upload all the aforementioned documents on the web portal of Haj Committee of India immediately upon receipt from the pilgrims.
- 6. The pilgrims should strictly adhere to the stipulated last date for deposit of Advance Haj Amount and submission of documents failing which their Haj seat shall be liable to be cancelled.
