**CIRCULAR**

**Subject: Extension of Last Date for Deposit of Haj Amount**

Reference to Circular No. 22 & 23 dated 04.12.2025, the last date for deposit of Haj Amount for pilgrims provisionally selected under Mehram Quota and those selected through the release of 3<sup>rd</sup> Waiting List is hereby extended till **22.12.2025**. All such pilgrims who are yet to deposit the Haj Amount are advised to remit the required amount of **₹2,77,300/-** (First Instalment: ₹1,52,300/- + Second Instalment: ₹1,25,000/-) within the extended timeline.

2. The payment, as specified above, can be made either through:
  - a. E-payment facility available on <https://hajcommittee.gov.in> or Haj Suvidha App using Credit Card / Debit Card / Net Banking,
  - OR
  - b. Specified Pay-in-Slip in any branch of State Bank of India or Union Bank India in the account of Haj Committee of India using Bank Reference Number available on HCOI website against their Cover number.
3. The unique Bank Reference Number provided to each Cover must be mentioned in the Deposit Receipt.
4. After depositing the specified amount, the pilgrims must upload the following documents on the HCOI website OR submit to the concerned State/UT Haj Committee latest by **24.12.2025**.
  - a. Signed copy of Haj Application Form (HAF) along with solemn declaration, undertaking, and passport declaration form
  - b. Copy of pay-in-slip / online receipt
  - c. Medical screening & fitness certificate (as per format available on the website)
5. The State/UT Haj Committees shall upload all the aforementioned documents on the web portal of Haj Committee of India immediately upon receipt from the pilgrims.

6. The Pilgrims should strictly adhere to the stipulated deadline for payment and submission of documents failing which their Haj seat shall be liable to be cancelled.
