**CIRCULAR**

**Subject: Release of First Waiting List for Haj-2027 G (1448 H)**

The Haj Committee of India (HCOI) is pleased to announce the release of the **First Waiting List comprising 6,864 seats** for Haj-2027 G (1448 H). Accordingly, waitlisted applicants, mentioned in **Annexure-I**, have been provisionally selected for Haj-2027 G (1448 H) as per their preference for Short Haj or Normal Haj.

2. The aforementioned applicants are required to deposit **₹1,52,300.00** (Advance Haj Amount - ₹1,50,000.00; Miscellaneous Dues - ₹2,000.00; and Non-Refundable Processing Fee - ₹300.00) latest by **30.08.2026**.

3. All pilgrims who were selected through Qurrah and are yet to deposit the requisite amount in full are also advised to pay the remaining amount on or before **30.08.2026**.

4. The payment, as specified above, can be made either through:

a. E-payment facility available on <https://hajcommittee.gov.in> or Haj Suvidha App using Credit Card / Debit Card / Net Banking

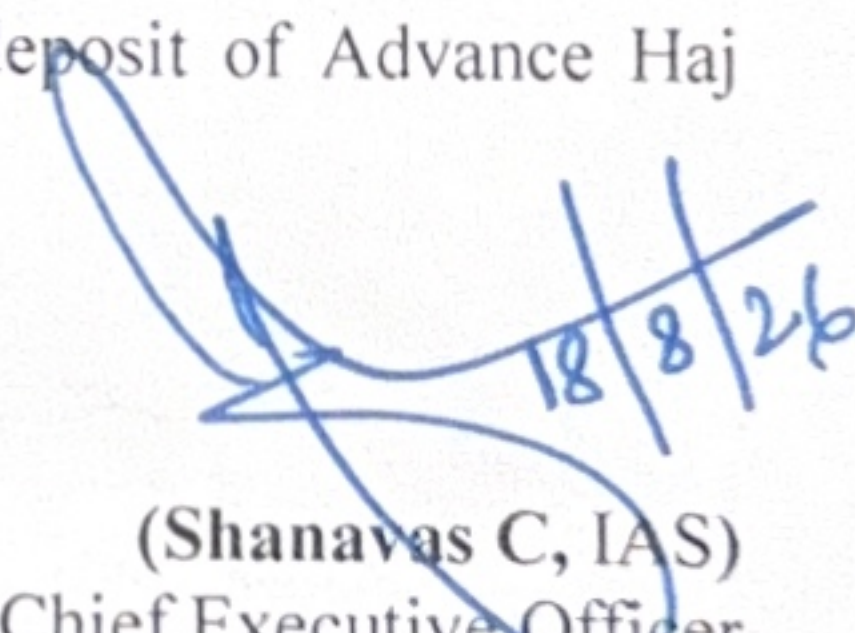

b. Specified Pay-in-Slip in any branch of State Bank of India or Union Bank of India in the account of Haj Committee of India using Bank Reference Number available on HCOI website against each Cover number.

5. The unique Bank Reference Number provided to each Cover must be mentioned in the Deposit Receipt.

6. A separate Circular regarding submission of the payment receipt, requisite documents, stage-I medical screening, and the subsequent process shall be issued in due course.

7. The pilgrims should strictly adhere to the stipulated last date for deposit of Advance Haj Amount, failing which their Haj seat shall be liable to be cancelled.

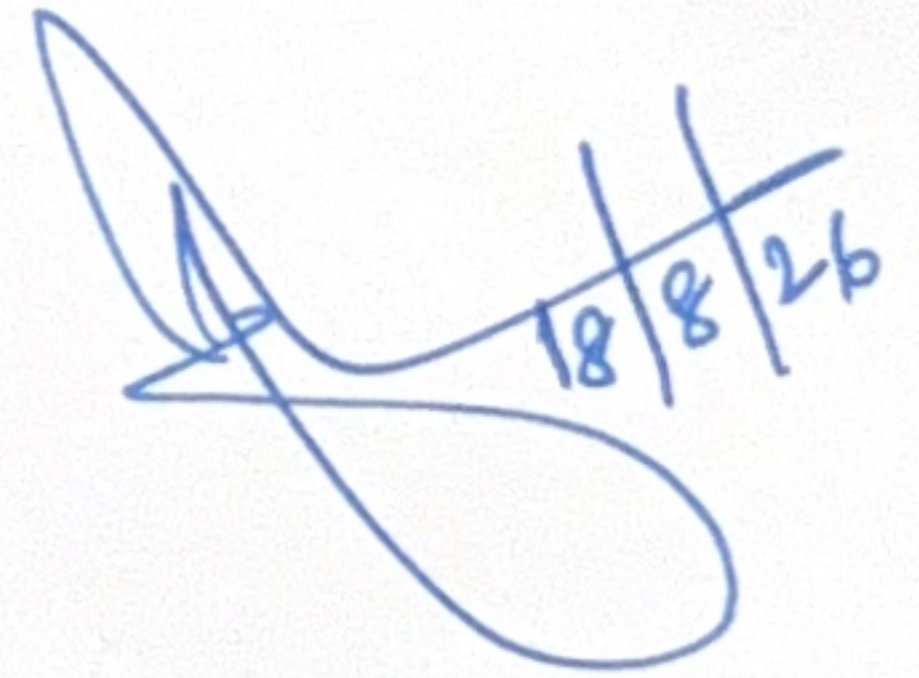
