1. **Material:** The softcopy of Indian Flag + Text etc. will be provided in Corel Draw or PDF format. The vendor should provide final proof of the Printed Baggage Tags within 2 days on receipt of softcopy for approval. The bidder should provide as many proofs as desired by Haj Committee of India. The bidder shall be responsible for in time delivery of Items against proper receipt from Haj Committee of India, strictly in consonance to the time schedule. The material of sample to be used for making of product, which is submitted with the bid should be exactly as per the specifications above, failing which the bids shall be declared non-responsive. The design, printing and production should be as per the details provided in the bid. Haj Committee of India reserves the right to reject/accept/modify/cancel the tender at any time/stage or relax/amend/withdraw any of the terms and conditions contained in the tender documents without assigning any reason. In case of withdrawal of bid, the Bid Security (EMD) shall stand summarily forfeited.
2. **Samples of Printed Baggage Tags:** The sample of Printed Baggage Tags to be shown on any working day during 10:30 Hrs. to 17:00 Hrs by visiting to the office of Chief Executive Officer Haj Committee of India at Bait-ul-Hujjaj (Haj House), 4<sup>th</sup> floor, 7-A, M.R.A. Marg (Palton Road), Mumbai-400 001.
3. **Delivery Period :** This is a **time bound supply** and the supplies are to be completed **within Seven (7) days** of final approval of the Samples to the Chief Executive Officer, Haj Committee of India, Bait-ul-Hujjaj (Haj House), 7-A, M.R.A. Marg (Palton Road), Mumbai-400 001.
4. **Bid Security :** The bidder has to submit the Bid Security (EMD) for an amount of Rs.3,00,000/- in the form of Demand Drafts drawn from any Nationalized Bank in favour of **"HAJ COMMITTEE OF INDIA, MUMBAI"**. No bid shall be entertained without Bid Security (EMD). The scanned copy of demand drafts for Bid Security (EMD) must be uploaded with the tender. The original demand draft must be submitted in a sealed envelope superscribed with **"The work of procurement and supply of Printed Baggage Tags for Haj-2025"** and dropped in the Drop Box kept in Room No.907 at 9<sup>th</sup> floor of Haj House Building, Bait-ul-Hujjaj (Haj House), 7-A, M.R.A. Marg (Palton Road), Mumbai-400 001 at the latest by **11:00 Hrs. on 06.04.2025.**
5. **Essential requirement for participation:** Bidders are requested to quote their offer by submitting bids in two packets (Technical bids and Financial bids) on e-procurement portal and drop in the drop box kept in Room No.907 at 9<sup>th</sup> floor of Haj House Building.
6. **Rate:** The bidder should quote the amount for each tendered item inclusive of taxes. The quantity of Printed Baggage Tags can be reduced or increased at the discretion of Competent authority of Haj Committee of India, Mumbai. The payment shall be made for the actual quantity procured. If the number of Printed Baggage Tags varies, the payment shall be made on pro-rata basis. No extra cost / charges shall be paid for loading / unloading and delivery of the tendered items.
7. **Mode of Supply:** Free on Road to the office of CEO, HCol.

8. **Mode of payment:** Payment will be made for the accepted quantity within 30 days after successful delivery and acceptance of the tender items. No advance payment shall be made. TDS shall be deducted, as per Income Tax Rules, from the payment bills.
9. **Eligibility Criteria of Technical Bid:** Bidders are requested to attach the following documents alongwith the bid:-

**10. Bid Evaluation Criteria:**

- Price bids of the bidder will be opened only of the bidders who fulfills the above technical qualification criteria.
- The bidders are advised to quote their rates inclusive of GST.

**11. General Terms and Conditions of the tender:**

- Technical bid shall be opened first and financial bid of only those bidders shall be opened, who qualify the technical bid.
- Incomplete or conditional tenders shall not be entertained. Haj Committee of India reserves the right to accept or reject any tender, in whole or in part thereof, without assigning/specifying any reason thereof.
- The Bid Security (EMD) shall stand forfeited if a bidder withdraws or amends the bid/tender or impairs or derogates from the tender in any respect during the period of bid, or in case successful bidder fails to accept order within the stipulated period. No interest will be payable on this amount. The Bid Security (EMD) shall also stand forfeited in the event of premature withdrawal of the tender by any of the bidders.
- Performance Security shall be submitted by the successful bidder within 30 days at 5% value of the total contract value in the form of Demand Draft / Bank Guarantee / Fixed Deposit Receipt in the name of "Haj Committee of India" with the validity of 14 months from the date of issue of Performance Security Deposit in order to fulfill the contractual obligations.

- v. The firms intending to participate in the tender process with their offer of tender are requested to read the terms and conditions of the contract.

## 12. General Terms and Conditions of the contract:

- i. The bidder must be in a position to supply/made available the requisite material with NEW PRINTER and Hand held reader of the described model in the required quantity for completion of the assignment.
- ii. The bidder should provide only NEW PRINTERS with cartridge hand held reader and required material of original quality.
- iii. The NEW MACHINES supplied by the bidders would not be returned to them after completion of the assignment. No request/claim in this regard would be accepted/considered.
- iv. Any deviation from specification or delay in supply of tendered item or damaged supply will attract heavy penalty to be decided by Haj Committee of India.
- v. Haj Committee of India reserves the right to reject the entire or part of supplies on account of defective material which is not found satisfactory as per specification. In such cases, Haj Committee of India shall be empowered to get the work completed from elsewhere and recover the consequential costs from the firm to which the contract was awarded.
- vi. The firm will have to ensure the safety of tendered item during packing and delivery.
- vii. The rates should be quoted in both words and figures.
- viii. If any firms withdrawing their offers after participating in the tendering process shall be liable for black listing from Haj Committee of India, forfeiture of EMD and other conditions stated above.
- ix. Conditional offers will not be accepted.
- x. In case of any dispute, the matter will be referred to an arbitrator appointed by Haj Committee of India.
- xi. All the disputes are subject to the Civil Courts within the limits of Mumbai Municipal Corporation.
- xii. Delivery of materials and goods to be made within 7 days of issue of Supply Order.
- xiii. **Liquidated damage:** If the bidder fails to supply or fulfill the contractual obligation, he is liable for recovery of liquidated damages for delay in supply as per the GFR -2017 and GOI rules.

xiv. In case of non-compliance, the offer of the bidder is liable for rejection.
