SECTION - II

1. BACKGROUND

- 1.1. The Haj Committee of India, a statutory body established under the Act of Parliament No. 35 of 2022 and functioning under administrative control of the Ministry of Minority Affairs, Government of India, hereby invites sealed bids (in two-bid system Technical and Financial) from reputed, eligible, experienced and qualified Indian smartwatch manufacturers (OEM), and technology providers or their authorized bidders for design, manufacture, supply and deployment of 1,22,518 smartwatches tailormade for Indian Haj pilgrims participating in Haj 2026, each device with preinstalled ready to use Local/Roaming IOT SIM/eSIM with preloaded 1 GB data valid for 60 days working in the Kingdom of Saudi Arabia.
- 1.2. This initiative is part of HCoI's ongoing commitment to modernize pilgrim support systems through digital innovation and enhanced safety protocols. The proposed smartwatch will serve as multi-functional wearable device, offering critical features such as:
 - 1.2.1. Live location GPS tracking to assist in group coordination, location sharing, and emergency response.
 - 1.2.2. Health monitoring tools including heart rate, oxygen saturation (SpO₂), step count, and sleep tracking to ensure timely health alerts and preventive care.
 - 1.2.3. Religious facilitation features, such as Namaz time alerts based on geolocation, Qibla direction, and Islamic notifications.
 - 1.2.4. Instant alert messaging from HCoI and group leaders, enabling timely dissemination of instructions, safety advisories, and schedule updates.
 - 1.2.5. Emergency SOS functionality, allowing pilgrims to signal distress and receive rapid assistance from designated support teams.
- 1.3. The selected bidder shall be responsible for ensuring technical readiness, multilingual interface or guide (including Hindi, Urdu, and English), training support, and onground deployment of smartwatches during the Haj period.

2. SPECIFICATIONS AND SCOPE OF WORK

2.1. Smartwatch Specifications

2.1.1. The smartwatches proposed under this tender document must meet the following minimum technical and functional requirements to ensure reliability, usability, and suitability for Haj pilgrims:

- 2.1.2. The device must be **fully compatible** with Android (Android 8.1 or above) enabling optional pairing for enhanced functionality.
- 2.1.3. The device must be equipped with cellular network support (4G LTE or higher), with seamless fallback to lower network bands (3G/2G or equivalent legacy networks) in areas where LTE connectivity is weak or unavailable, ensuring uninterrupted communication.
- 2.1.4. Haj Suvidha App Integration will be done by the supplier in collaboration with the system integrator of HCoI. The device must be capable of seamless integration with the Haj Suvidha mobile app, dashboard, and any other android wearable platform feature proposed by HCoI. The device should support real-time updates, health notifications, and Namaz time alerts for pilgrims and support staff. The device shall include the following features:
 - a. Digital ID integration
 - b. Navigation and guidance system
 - c. Multilingual interface
 - d. Prayer and ritual reminders
 - e. SOS emergency support
 - f. Health and medical alerts

- g. Fitness tracker and pedometer
- h. Broadcast alerts from authorities
- i. Weather updates
- j. Location-based info on nearest health and transport facilities
- k. Anti-tamper/removal alert
- 1. Pilgrim feedback and assistance request button
- m. Battery-saving mode.
- 2.1.5. The device must be designed for **secure and reliable connectivity**, with support for encrypted data exchange and remote device management.
- 2.1.6. The bidder shall ensure that all supplied devices are **pre-configured**, **tested**, **and ready for deployment**, with necessary accessories (charging cables, manuals, protective cases (if applicable) included.
- 2.1.7. The device is to be branded/co-branded as "Haj Committee of India".
- 2.1.8. The supplier has to distribute the devices to the legitimate pilgrims at designated Embarkation Points across India.
- 2.1.9. The device must accept over-the-air (OTA) updates for firmware and feature enhancements during the Haj season.
- 2.1.10. The bidder shall ensure that all supplied smartwatches are **durable**, **user-friendly**, **and optimized for field use** during the Haj journey, with multilingual interface or guide options (including Hindi, Urdu, and English) and robust battery performance suitable for extended outdoor activity.
- 2.1.11. Warranty and After-Sales Support (Minimum 01 Year): The selected bidder shall provide door-step/onsite replacement warranty of at least one (01) year from the date of final delivery/distribution and acceptance of the smartwatches by the Haj Committee of India (HCoI). This warranty must cover:
 - **2.6.1.1 Manufacturing defects** in hardware components.
 - **2.6.1.2 Software malfunctions** or firmware issues not caused by misuse.
 - **2.6.1.3 Battery performance degradation** beyond acceptable thresholds.
 - **2.6.1.4** Sensor failures (e.g., heart rate, SpO₂, GPS).
 - **2.6.1.5 Display or connectivity issues** under normal usage conditions.
- 2.1.12. During the Haj season, the bidder shall immediately provide replacement of defective devices, while during the remainder period of warranty, the bidder shall provide free-of-cost repair of defective smartwatch units or replacement for beyond repair cases. The bidder must have repair facilities with spare parts.
- 2.1.13. The bidder must maintain a spare unit buffer stock (minimum 2% of total supply) for immediate replacement during deployment or during pilgrims stay in Kingdom of Saudi Arabia.

- 2.1.14. To ensure uninterrupted service and timely replacement of defective smartwatch units, the selected bidder shall deploy at least one qualified technical representative at 18 designated embarkation points (distribution points) in India, and two qualified technical representatives for round the clock support and service in the two holy cities of the Kingdom of Saudi Arabia—Makkah and Madinah—for the entire duration of the Haj season.
- 2.1.15. Data Security: End-to-end encryption (TLS 1.2+); secure OTA updates.

2.2. Specifications of SIM Card

2.2.1. Each Smart Watch unit must be supplied with pre-inserted/preinstalled ready to use IOT SIM/eSIM meeting the following specifications with preloaded 1 GB data valid for 60 days from the date of distribution/deployment:

2.3. Scope of Work / Bidder's Responsibilities

- 2.3.1. The bidder should manufacture and supply smartwatches that comply with the technical specifications, durability standards, and certification requirements outlined in the Tender document.
- 2.3.2. The HCoI reserves the right to increase or decrease the order quantity at the time of contract placement. The HCoI may also increase or decrease the contracted quantity by up to 5% during the validity of the contract at the same rates and terms.
- 2.3.3. The products supplied must be brand new, unused, and free from defects.
- 2.3.4. The products must be BIS-certified and compliant with Indian government norms.
- 2.3.5. The products must be capable of functioning reliably in extreme climatic conditions and high-density crowd environments typical of Haj operations.
- 2.3.6. The bidder shall ensure device configuration & customization as per the requirement of Haj Committee of India.
- 2.3.7. The device must have emergency contact details and SOS functionality.

- 2.3.8. The bidder must provide support to establish compatibility with HCoI's monitoring dashboard, mobile apps, or backend systems as per requirement.
- 2.3.9. The bidder must package each unit with charging cables, manuals, protective cases if applicable, warranty card and support contact details.
- 2.3.10. The device must have unique pilgrim ID label / name or pilgrim cover number embossed on Smart Watch, in a manner to be decided by HCoI.
- 2.3.11. The bidder shall maintain a master inventory list with serial numbers, batch codes, and delivery status.
- 2.3.12. The bidder shall be responsible for delivering and distributing smartwatches to each pilgrim at designated embarkation points or HCoI offices across India, in accordance with the approved delivery schedule to be provided by HCoI.
- 2.3.13. The bidder is responsible for procuring SIM cards from Indian/Saudi Telecom companies, installing them in the smartwatches, and ensuring activation prior to distribution.
- 2.3.14. The bidder shall ensure timely dispatch and secure transit.
- 2.3.15. The bidder shall be responsible for clearing transportation and certification required for transport and distribution of smartwatch to the Haj pilgrims.
- 2.3.16. The bidder shall be responsible for taking all necessary certificates, licenses, any clearance required either by India government or from Saudi government or by custom or any authorizes.
- 2.3.17. The bidder must ensure buffer stock availability for replacements of faulty smart watch at the point of distribution and in two holy cities in Kingdom of Saudi Arabia (Makkah and Madinah)
- 2.3.18. The selected bidder must replace the faulty smart watch within 12 hours of the claim which is made either at distribution place or in two holy cities in Kingdom of Saudi Arabia (Makkah and Madinah) during the Haj period.
- 2.3.19. The bidder shall submit periodic reports to HCoI on:
 - Delivery status.
 - Device activation and usage.
 - Warranty claims and support tickets.
- 2.3.20. The bidder shall maintain full compliance with:
 - Data privacy norms.
 - Government procurement guidelines.
 - Audit and inspection protocols.

- Compliance with Personal Data Protection Act.
- 2.3.21. Coordination & Communication: The bidder shall appoint a dedicated project manager to liaise with HCoI, CGI, Jeddah and MoMA.
- 2.3.22. Warranty & Support Services: The bidder shall provide minimum 1-year onsite/doorstep replacement warranty for Smart Watch.
- 2.3.23. The bidder shall set up a support helpline and service escalation matrix active during the Haj season.
- 2.3.24. Software & MIS Integration: The bidder shall ensure:
 - 2.3.24.1. Real-time location tracking on cloud dashboard.
 - 2.3.24.2. Health parameter monitoring (HR, SpO2, steps, sleep, falls).
 - 2.3.24.3. SOS button for emergencies with direct alert to control room.
 - 2.3.24.4. Attendance/entry recording at Haj sites.
 - 2.3.24.5. Data exportable in CSV/Excel for reports.
- 2.3.25. The bidder shall ensure that technical support team is available in India & KSA during Haj period.
- 2.3.26. The bidder shall ensure pre-testing of devices and SIM before distribution.

2.4. Inspections and Tests

- 2.4.1. The bidder shall, on their own cost, facilitate HCoI to inspect and/or test the goods, in order to verify their conformity with the specifications set forth in the Contract.
- 2.4.2. The HCoI shall notify the Bidder in writing, in a timely manner, of the identity and details of any representatives or third parties to carry out such inspections and/or tests.
- 2.4.3. The Bidder shall provide reasonable access, assistance, and facilities to the HCoI or its representatives for carrying out such inspections and/or tests.
- 2.4.4. Should any inspected or tested goods fail to conform to the specifications, the HCoI shall have the right to reject such goods.
- 2.4.5. Upon rejection, the Bidder shall, at its own cost and without delay, replace the rejected Goods with Goods that fully comply with the Contract specifications.
- 2.4.6. All replacements shall be carried out by the Bidder/ OEM free of cost to the HCoI.
- 2.4.7. Any replaced Goods shall be subject to re-inspection and/or re-testing by the HCoI or its authorized representative, at no additional cost to the HCoI.
- 2.4.8. The decision of the HCoI regarding the conformity of the Goods to the specifications shall be final and binding on the Bidder.

SECTION - III

1. INSTRUCTIONS TO BIDDERS

- 1.1. Bidders are advised to visit HCoI website / CPPP website regularly to keep themselves updated, for any changes/ modifications in the Tender Enquiry Document and any corrigendum or extension, till final closing date of submission of bid.
 - 1.2. The EMD/Bid Security in the form of Bank Guarantee / Demand Draft of ₹4,00,00,000/- (Rupees Four Crore Only) in favour of Haj Committee of India should be submitted along with technical bid.
- 1.3. The bidders registered under Startup India, Micro, Small Enterprises (MSEs) exempted from paying Earnest Money Deposit (EMD) fee must submit necessary documents supporting the same. After proper verification, payment of EMD fees may be exempted.
- 1.4. EMD fees is returned back to all unsuccessful bidders once the evaluation is completed and the contract is signed by the successful bidder.
- 1.5. The bid validity period will be 180 days.
- 1.6. Estimated value of Bid is ₹863,751,900.00 (Rupees Eighty-Six Crore Thirty-Seven Lakh Fifty-One Thousand Nine Hundred Only).
- 1.7. No bidder shall be permitted to submit more than one Bid for the same work/same NIT number.
- 1.8. The specifications, dimensions and terms & conditions once fixed by the HCoI shall not be allowed to be changed or deviated by the bidder and the bidder has to strictly follow them. It is the responsibility of the bidder to test the quality, technical specifications of the goods before supply to the designated locations.
- 1.9. Notwithstanding anything to the contrary contained in this BID, that any conditions or obligations imposed on the bidder hereunder shall continue to have effect.
- 1.10. The bidder shall furnish in the format annexed for Technical Bid (along with specified annexures) and for Financial Bid. Bid amount shall be indicated clearly in both figures and words, in Indian Rupees (INR) and shall be signed by the bidder or the bidder's authorized signatory. In the event of any difference between figures and words, the amount indicated in words shall be taken into account and no argument/ reason and claim whatsoever shall been entertained.

- 1.11. The Bid Security for unsuccessful bidders shall be on hold till finalization of orders on L1 rates to the selected bidder. Selected bidder's security deposit will be returned after submission of Performance Bank Guarantee.
- 1.12. Any conditions or qualifications or any other stipulations contained in the Bid shall render the Bid liable to be rejected as a non-responsive Bid.
- 1.13. The Bid and all communications in relation to or concerning the Bidding Documents and the Bid shall be in English language.
- 1.14. The Tender document and all attached documents, provided by the Authority are and shall remain or becomes the property of the Authority and are transmitted to the Bidders solely for the purpose of preparation and the submission of a Bid in accordance to terms & conditions. Bidders are to treat all information as strictly confidential and shall not use it for any purpose other than for preparation and submission of their Bid. The same provisions shall also apply mutatis mutandis to Bids and all other documents submitted by the Bidders, and the Authority will not return to the Bidders any Bid, document or any information provided along therewith.
- 1.15. This BID is not transferable.
- 1.16. Any award of work pursuant to this BID shall be subject to the terms & conditions of tender document.
- 1.17. **Blacklisting/Conviction:** The Bidder (OEM/Bidder) must not have been blacklisted, banned, or convicted by any Court of Law for any criminal or civil offences, nor declared ineligible by the Central Government, any State Government, Union Territories, or any Public Sector Undertaking (PSU) at the time of submission of the bid.
- 1.18. The Authority shall place sole reliance on the self-attested certifications submitted by the Bidder in this regard, as part of its Technical and Financial Bid.

In line with Policy Circular No. 1(2) (1)/2016-MA Dated 10th March, 2016 of the Ministry of Micro, Small & Medium Enterprises on "Relaxation of Norms for Startups and Micro & Small Enterprises in Public Procurement on Prior Experience and Prior Turnover Criteria", the Criteria of Prior Turnover and Prior Experience are relaxed for MSEs, subject to meeting of quality and technical specifications.

3. BID EVALUATION CRITERIA

- 3.1. **Technical Evaluation Criteria:** Bidders who fulfill all pre-qualification and eligibility criteria shall be deemed qualified to proceed to the subsequent stages of evaluation, which include Technical and Financial assessments as outlined in the Tender document. A bidder may be disqualified if TEC is not satisfied with Execution Capability and Plan submitted / presented by the concerned bidder.
- 3.2. **Financial Bid Evaluation:** The Financial Bids of all technically qualified bidders shall be opened on the scheduled date, in the presence of authorized representatives of the participating bidders, as per the procedure. The contract shall be awarded to the bidder whose financial bid is the lowest (L1) among those who meet all qualifying criteria.
- 3.3. **Award of Contract:** The contract shall be awarded to the bidder whose financial bid is the lowest (L1) among those meeting all qualifying criteria and whose proposal is deemed substantially responsive, as per the evaluation process defined in the Tender document.
- 3.4. **Notification of Award:** Before the expiry of the bid validity period, HCoI shall notify the successful bidder in writing that their proposal has been accepted. If the procurement process is not completed within the stipulated time, HCoI may request bidders to extend the validity of their bids. This notification shall constitute the award of contract. Upon receipt of the Performance Bank Guarantee from the successful bidder, HCoI will initiate the return of their Earnest Money Deposits (EMDs).
- 3.5. **Contract Finalization and Award:** The HCOI shall reserve the right to further discuss commercial terms with the successful bidder, as per CVC guidelines.
- 3.6. **Right to Accept and To Reject Any or All Proposal(s):** HCoI reserves the right to accept or reject any proposal, in whole or in part, and to annul the tendering or public procurement process at any stage prior to the award of the contract. This may be done without assigning any reason and without incurring any liability whatsoever to the

affected bidder(s). HCoI is under no obligation to inform the bidder(s) of the grounds for such action.

- 3.7. **Performance Guarantee:** The selected bidder shall furnish a Performance Bank Guarantee (PBG) amounting to 5% of Total Contract Value (including taxes and levies) within 3 days from the date of Notification of Award. This period may be extended by an additional 02 days with prior approval of the CEO, Haj Committee of India. The PBG should remain valid until the completion of Haj Season 2026, i.e., the commencement of the last return Haj Charter flight to India.
- 3.8. **Signing of Contract:** Upon notification of award, HCoI shall enter into a formal contract with the successful bidder. The contract shall incorporate all terms and conditions of the tender, including pre-bid clarifications and the bidder's submitted proposal.
- 3.9. **Annulment of Award and Forfeiture of Performance Guarantee:** If the successful bidder fails to accept the Draft Legal Agreement or the Terms and Conditions specified in the tender documents, HCoI shall have the right to annul the award. In such cases, HCoI may either award the contract to the next best evaluated bidder or initiate a fresh procurement process. Further, HCoI reserves the right to invoke the Performance Bank Guarantee (PBG) submitted by the defaulting bidder.

4. FORCE MAJEURE

- 4.1. Occurrence of a Force Majeure event shall not absolve the bidder from liability for forfeiture of EMD, Performance Guarantee, liquidated damages, or termination due to default.
- 4.2. "Force Majeure" refers to unforeseen events beyond the control of the bidder, without any fault or negligence on their part. Such events may include, but are not limited to, acts of government, war, civil unrest, fire, flood, epidemic, quarantine restrictions, or transport embargoes.
- 4.3. If a Force Majeure event occurs, the bidder shall promptly notify HCoI in writing, stating the nature and cause. Unless otherwise instructed, the bidder shall continue to perform contractual obligations to the extent possible and explore reasonable alternatives.
- 4.4. If the bidder is unable to perform a significant portion of the services for up to 30 days due to Force Majeure, HCoI may terminate the contract by giving at least 30 days' written notice.

6. DELIVERY TIMELINE

The successful bidder shall ensure delivery of the complete consignment of the required goods at the designated locations, as specified by the Haj Committee of India (HCOI) in agreement, within a maximum period of 60 calendar days from the date of issuance of the Purchase Order (PO).

7. PENALTY & LIQUIDATED DAMAGES

- 7.1. If the Bidder fails to supply, configure, activate SIMs, or deploy the devices, complete distribution, or meet any project milestone within the stipulated timeline, the HCoI shall impose Liquidated Damages (LD) at the rate of 0.5% (one-half percent) of the total contract value for each week of delay or part thereof, subject to a maximum of 10% of the total contract value.
- 7.2. LD shall be calculated on the total contract value, not merely on the delayed portion.
- 7.3. Imposition of LD shall be without prejudice to any other remedies available to the Purchaser, including termination of contract.
- 7.4. If the supplied devices/products/services fail to meet the required technical specifications, performance parameters, or SLAs, the following penalties shall apply:
 - 7.4.1. Device-level failure rate exceeding acceptable limit of 2% during Haj in KSA: Replacement within 24 hours or penalty of 110% price of device.
 - 7.4.2. Failure to provide onsite/doorstep warranty support after Haj period in India: Penalty of ₹100 per device per day of non-compliance.
- 7.5. Imposition or non-imposition of penalty does not waive the HCoI's right to enforce future compliance or seek damages for consequential losses.
