Sub:- Haj -2019. Conduct of Training of Khadim-ul-Hujjaj.

In continuation of our earlier Circular No.6 dated 28.12.2018 for Selection of Khadim-ul-Hujjaj (KuH) for Haj- 2019.

2. Two (2) days Training Programme of Khadim-ul-Hujjaj for Haj-2019 will be conducted on **9<sup>th</sup> & 10<sup>th</sup> February, 2019** in the office of Haj Committee of India, Bait-ul-Hujjaj (Haj House), 7-A, M.R.A. Marg (Palton Road), Mumbai- 400 001. The registration will start at 8:00 a.m. on **9<sup>th</sup> February, 2019** participants are to occupy their seats by 09:00 a.m. The training session will be held from 9:30 a.m. to 7:00 p.m. The trainees have to arrange their return journey only after 08:00 p.m., of 10<sup>th</sup> February, 2019 as their presence shall be mandatory for full day.

3. The Hon'ble Minister of Minority Affairs will be inaugurating the said programme and Chairman, HCoI will grace the occasion.

4. Haj Committee of India will provide simple accommodation to the candidates attending this training. **No Travelling Allowance will be admissible to the candidates for attending the training programme.** The candidates who attend complete 2 days training Programme without fail shall be given Certificate for attendance of training of KuH. After training the certificate will be send to their respective State Haj Committees. This certificate is required to be shown by the selected Khadim-ul-Hujjaj at their respective Embarkation Point, and it is further required to be submitted to the Consul General of India, Jeddah on arrival in Kingdom of Saudi Arabia. It may be ensured by all the candidates that there should be 100% participation of the KuH in the training programme including those are in the waiting list of their State.
