Subject: Release of 2nd Waiting List for Haj- 2023.

1453 Haj seats have now become available due to cancellations received from various States/UTs. A statement showing cancellations received from the respective States/UTs and the wait-listed pilgrims for Haj-2023, who are now provisionally selected for Haj Pilgrimage in terms of Guidelines for Haj-2023 is enclosed herewith.

2. The aforesaid provisionally selected pilgrims are required to deposit the stipulated full Haj Amount in lumpsum in respect of respective Embarkation Points (as per HCoI Circular No.13 dated 06.05.2023).

3. Payments can be made either,

- Online at <http://hajcommittee.gov.in> or
- In Haj Committee of India account maintained with SBI or account maintained with UBI through any branch of SBI/UBI having core Banking System by using unique Bank Reference Number in the Specified Pay-in-slip on website.
- By cheque of any branch of SBI/UBI in favour of the respective Bank.

4. These provisionally selected pilgrims after depositing the amount, have to submit Pay-in-Slip, Haj Application Form (HAF), Solemn Declaration, Medical Screening & Fitness Certificate (Government Medical Officer/Doctor) and COVID double dose vaccination certificate alongwith Original International Passport to the concerned State Haj Committee on or before 31.05.2023.

5. The State Haj Committees shall make available the valid machine readable international passports after uploading all documents along with pay-in-slip, Medical Screening and Fitness Certificate and COVID double dose vaccination certificate to Haj Committee of India on or before 31.05.2023 on priority basis.
